JPM confirmed:

As on Luxembourg holidays BGF funds are closed the pay date is affected as the pay date is Ex-Date + 5 business days not calendar days.

The dividend process requires 5 business days after the ex-date to complete." So a Lux holiday, regardless of where it falls, constitutes a non-business day so therefore Ex-Date+5BD would be affected.
