Schroder International Selection Fund (the “Company”) – Asian Dividend Maximiser (the “Fund”)

We are writing to inform you that on 10 September 2026 (the “Effective Date”) the investment policy of the Fund will change to permit the Fund to invest up to 20% of its net assets directly or indirectly (for example through derivatives) in China A-Shares. This is an increase from the current limit of up to 10% of the Fund’s net assets.

Background and rationale

The change is intended to ensure that the investment policy more accurately reflects the Fund’s potential exposure to China A-Shares and provides sufficient flexibility for portfolio construction.

Although China has reduced as a proportion of the Fund’s regional opportunity set in recent periods, we believe the investment opportunity remains significant. The increased limit provides the flexibility to increase exposure where appropriate.

Exposure to China A-Shares will continue to be through Shanghai-Hong Kong Stock Connect and Shenzhen-Hong Kong Stock Connect and shares listed on the STAR Board and the ChiNext. For an explanation of these terms please refer to the prospectus of the Company.

Full details of the changes being made to the Fund’s investment policy can be viewed in Appendix I of this letter. This change will be also reflected in the Fund’s pre-contractual disclosure (included in Appendix IV of the prospectus) in accordance with SFDR and Commission Delegated Regulation (EU) 2022/1288.

The extent of the change to the risk/reward profile of the Fund as a result of this change is non-significant.

There are no other changes to the Fund’s investment strategy and the operation and/or manner in which the Fund is being managed following this change.

The ISIN codes of the Fund’s share classes affected by the above change are listed in Appendix II of this letter.

Redeeming or switching your shares to another Schroders fund

We are writing to inform you that on 10 September 2026 (the “Effective Date”) the Fund’s investment objective and policy will be broadened to permit investment in European, non-Eurozone, countries.

Rationale

Broadening of investment objective and policy to permit investment in European, non-Eurozone, countries

The Fund’s investment objective and policy currently require it to invest at least two-thirds of its assets in fixed and floating rate securities issued by governments of countries whose currency is the Euro. However, this does not reflect the way the European fixed income market has developed over time and, in practice, limits the Fund’s ability to invest.

To address this issue, the investment objective and policy will be updated to allow the Fund to invest in bonds that are denominated in, or hedged to, the Euro, rather than restricting investments based on the issuer’s domestic currency. This change will broaden the Fund’s primary investment universe to include European governments that do not use the Euro (for example Sweden, Poland, Hungary and Romania) and quasi-sovereign and supra-national issuers guaranteed by European governments, for example European Union bonds. The Fund will continue to invest only in securities that are denominated in, or hedged to, the Euro.

The changes will be also reflected in the Fund’s pre-contractual disclosure (included in Appendix IV of the prospectus) in accordance with SFDR and Commission Delegated Regulation (EU) 2022/1288.

Schroder International Selection Fund (the “Company”) – Global Smaller Companies (the “Fund”)

We are writing to inform you that on 10 September 2026 (the “Effective Date”) the investment policy of the Fund will change to permit the Fund to invest less than 20% of its net assets directly or indirectly (for example through derivatives) in China A-Shares. This is a decrease from the current limit of less than 30% of the Fund’s net assets.

Background and rationale

The Fund’s exposure to China A-Shares has been low in recent periods, with no current exposure and a maximum exposure of less than 1% over the past 12 months. As such, the current limit of 30% is not representative of the Fund’s typical investment approach.

However, China A-Shares form part of the broader global opportunity set, and the Fund’s investment manager may allocate to this area where attractive opportunities arise. The revised limit of 20% is therefore intended to better reflect the Fund’s expected level of exposure over time, while maintaining appropriate flexibility for portfolio construction.

Exposure to China A-Shares will continue to be through Shanghai-Hong Kong Stock Connect and Shenzhen-Hong Kong Stock Connect and shares listed on the STAR Board and the ChiNext. For an explanation of these terms please refer to the prospectus of the Company.

Full details of the changes being made to the Fund’s investment policy can be viewed in Appendix I of this letter. This change will be also reflected in the Fund’s pre-contractual disclosure (included in Appendix IV of the prospectus) in accordance with SFDR and Commission Delegated Regulation (EU) 2022/1288.

The extent of the change to the risk/reward profile of the Fund as a result of this change is non-significant.

There are no other changes to the Fund’s investment strategy and the operation and/or manner in which the Fund is being managed following this change.
