主旨：謹通知本公司總代理之 PIMCO 絕對收益債券基金以及 PIMCO 動態多元資產基金之特定股份類別績效指標變更事宜，詳如說明。

說明：

- 一、因應 LIBOR 退場轉換計畫，本公司總代理之 PIMCO 絕對收益債券基金以及 PIMCO 動態多元資產基金中特定股份類別之績效指標 (Benchmark) 將從「美元倫敦同業拆款利率指數(USD LIBOR (London Interbank Offered Rate))」修改為「ICE 美國銀行擔保隔夜融資利率指數(ICE BofA SOFR Overnight Rate Index)」。
- 二、此次修改僅變更基金績效指標，並未影響基金投資策略。
- 三、調整後之公開說明書預計將於愛爾蘭時間 2022 年 7 月 1 日向愛爾蘭中央銀行申報，總代理人並將依法將公開說明書中譯版上傳至境外基金資訊觀測站資訊公告平台。

本函旨在通知台端相關績效指標之未來變動。

用以衡量附錄A所列任何股份類別績效表現之績效指標應從「美元倫敦同業拆款利率指數(USD LIBOR (London Interbank Offered Rate))」修改為「ICE美國銀行擔保隔夜融資利率指數(ICE BofA SOFR Overnight Rate Index)」。

上述變更係因規管 LIBOR 之英國金融行為監管局逐步停止採用 LIBOR，針對以歐元、英鎊及瑞士法郎計價之LIBOR績效指標，PIMCO已於2021年7月完成第一階段變更。

實施本次變更之相關支出及/或費用將由管理機構承擔。

反映該變更之修訂後增補文件(如適用)及主要投資人資訊文件，預計將於2022年7月1日當日或前後經愛爾蘭中央銀行簽證，並將適時公告於本公司網站 www.pimco.com。

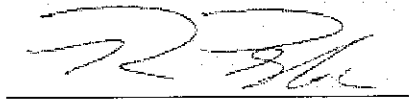

- LIBOR Transition Phase II and change of benchmarks

Dear Shareholder,

We are writing to inform you of upcoming benchmark changes.

The benchmark used to measure performance for any of the share classes detailed in Appendix A shall change from the "USD LIBOR (London Interbank Offered Rate)" to the "ICE BofA SOFR Overnight Rate Index".

The benchmark used to measure performance for any of the share classes detailed in Appendix B shall change from the "SGD LIBOR (London Interbank Offered Rate)" to the "Singapore Interbank Overnight Rate Average – SORA".

The above changes arise from the phasing out of the use of the LIBOR by the United Kingdom's Financial Conduct Authority which regulates LIBOR, the first phase of which was completed by PIMCO in July 2021 for LIBOR benchmarks denominated in EUR, GBP and CHF.

The costs and/or expenses that will be incurred in connection with the implementation of the changes will be borne by the Manager.

The updated Supplements, where applicable, and Key Investor Information Documents reflecting the changes are expected to be noted by the Central Bank of Ireland on/around **1 July, 2022** and will be available on PIMCO's website: www.pimco.com in due course.

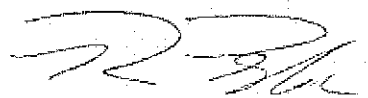
