- 一、謹轉知 PIMCO Funds: Global Investors Series plc 系列基金（下稱「PIMCO GIS 系列基金」）之子基金 PIMCO 動態多元資產基金（已於 113 年 9 月 3 日終止於我國募集及銷售，下稱「合併子基金」）之股東已於 113 年 10 月 18 日之臨時股東大會通過決議，同意將合併子基金與 PIMCO GIS 系列基金之另一子基金 PIMCO Strategic Income Fund（該子基金並未經核准或申報生效於我國募集與銷售，下稱「接收子基金」）依據 113 年 9 月 9 日之股東通知（下稱「股東通知」）中所詳載之條款與條件進行合併，並授權 PIMCO GIS 系列基金之董事進行一切必須步驟以執行合併。詳情請參 PIMCO GIS 系列基金於 113 年 10 月 18 日發送之股東公告如附件一。

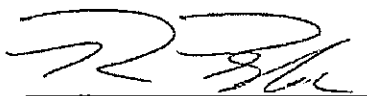
